

T20 World Cup 2024 Schedule PDF Download Free: ICC Announces Dates, Venues, and Match Timings

May 29, 2024 - The International Cricket Council (ICC) has released the complete schedule for the ICC Men's T20 World Cup 2024, which is set to take place in the West Indies and the United States from June 1 to 29, 2024. The schedule includes all the fixtures, match timings, and venues for the 20 participating teams, which can be downloaded as a free PDF from official sources.

The tournament will feature a new format, with the 20 teams divided into four groups of five teams each. The top two teams from each group will move to the Super Eight phase, where they will be further divided into two groups of four teams each. The top two teams from each of these groups will then qualify for the semi-finals, followed by the final match on June 29, 2024, in Barbados.

The schedule includes a total of 45 matches, with the opening fixture between the United States and Canada taking place on June 1, 2024, in Dallas. The most awaited match between India and Pakistan will be played on June 9, 2024, in New York. The knockout stage will begin on June 19, 2024, with the semi-finals scheduled for June 26 and 27, 2024, in Guyana and Trinidad & Tobago, respectively. The final match will be held on June 29, 2024, in Barbados.
